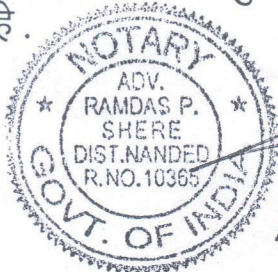

CHANGE REPORT UNDER SECTION 22 OF THE MAHARASHTRA
PUBLIC TRUSTS ACT, 1950.

JUDGMENT

(Pronounced in open court on : 23/09/2021)

1. This is a change report under section 22 of the Maharashtra Public Trusts Act, 1950 ('the Act' for short) pertaining to Marathwada Gramin Shikshan Sanstha Himayatnagar Tq. Himayatnagar District Nanded. P. T. R. No. F-529 (Nanded) (hereinafter referred to as 'the trust').

2. The reporting trustee/applicant's case in brief is that the secretary of the trust Dr. Devendra Balajirao Joshi expired. Also, treasurer and member of

the trust Arun Keshav Kulkarni and Dr. Mrunalini Amitabh Dayal resigned from their posts. Their resignations were accepted and also, Aruna Arun Kulkarni, Supriya Vishal Patil and Shivam Suryakanta Patil applied for life-membership of the trust. Executive committee meeting for granting memberships and for filling the vacant posts was called by issuing notices to all the members of the trust. The applications were accepted and vacant posts filled by unanimous resolutions. The applicant prayed to accept the change report and to amend the Schedule – I in respect of the trust to that effect.

3. Trustees on record and those shown in the application (Exh.1) filed their consent through their advocate (Exh.6) to the change report. None objected the change report and it remained uncontested.

3. Perused the evidence on record. Heard the learned Advocate for the applicant. Following are the points arising for my determination along with my findings thereon and reasons therefor.



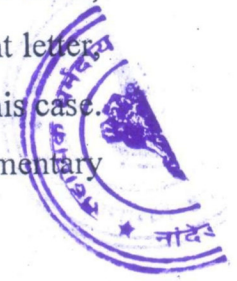
REASONS

Point No.1

4. The applicant, vide his affidavit in lieu of examination-in-chief, deposed (Exh.7) as per his case. The applicant has also produced consent letter, no-objection certificate, copies of notices and resolutions in support of his case. Since the change report remained uncontested, the oral and documentary evidence of the applicant remained unchallenged.

5. The evidence on record manifests that the secretary of the trust Dr. Devendra Balajirao Joshi expired on 24.01.2021, which can be seen from the death certificate (Exh.21). Aruna Arun Kulkarni, Supriya Vishal Patil and Shivam Suryakanta Patil (Exh.08 to 10) applied for life-membership of the

trust. Their applications were accepted by unanimous resolution (Exh.17) in executive committee meeting dated 14/03/2021 convened vide notice (Exh.16) dated 04/03/2021. They have paid life-membership fees vide receipts (Exh.11 to 13) and accordingly, their names have been entered in the membership register (Exh.20) of the trust.

6. The evidence further shows that Arun Keshav Kulkarni and Dr. Mrunalini Amitabh Dayal resigned from their posts (Exh.14 and 15) of their posts of treasurer and member of the executive committee of the trust. Their resignations were accepted and vacant posts were filled by appointing new members as shown in change report (Exh.1) by unanimous resolution (Exh.19) in executive committee meetings dated 09/05/2021 convened vide notice (Exh.18) dated 01/05/2021.

7. The change can be held to be legal if it is not unlawful and has been effected in accordance with the bye-laws of the trust. Scrutiny of the procedure adopted in effectuating the aforementioned change in light of the bye-laws of the trust produced by the applicant, shows that all requisites for effectuating the change as specified in the bye-laws have been complied with.

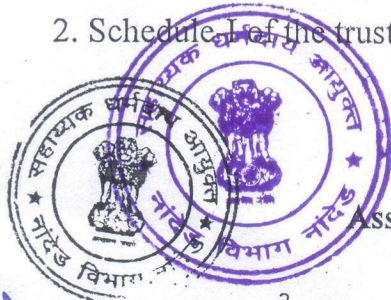
8. Thus, the foregoing findings lead to a conclusion that the reported change is legal and has occurred in due conformity with the bye-laws of the trust. The reported change is valid and there appears no impediment in accepting the same. Resultantly, I answer point no.1 in affirmative and in answer to point no.2 pass the following order.

ORDER

1. The change report is accepted.
2. Schedule I of the trust be amended accordingly.
